MULLIGAN CARTS, LLC hereby warrants that any refurbished cart purchased from MULLIGAN CARTS, LLC will be free from defects in material and workmanship for twelve (12) months from the date of purchase, subject to the limitations stated below. DURING THE WARRANTY PERIOD, MULLIGAN CARTS, LLC will repair or replace any part determined to be defective due to faulty workmanship or material. Parts used in warranty repairs will be warranted for the balance of the vehicle's warranty period. All parts replaced under warranty become property of MULLIGAN CARTS, LLC. The warranty is non-transferable to a different owner.

LITHIUM BATTERY PACKAGE: ECO Lithium batteries are warranted directly through ECO Battery LLC. See www.ecobattery.com for details.

EXCLUSIONS from this Warranty shall include:

- Abnormal strain, neglect, or abuse, including lack of proper maintenance, and use contrary to the manufacturer's operator's manual.
- Damage due to accident, collision, improper transportation, theft or vandalism.
- Installation of parts or accessories that were not installed at the time of delivery of your cart.
- Fading, rust, or deterioration, of any original components of the vehicle or any parts replaced during the refurbishment of the vehicle.
- Routine maintenance items, normal wear and tear, cosmetic deterioration, or electrical components damaged as a result of fluctuations in electrical current.
- Acts of God, e.g. lightning, hail damage, flooding, fire, etc. or other events over which MULLIGAN CARTS, LLC has no control.
- Noises that develop due to normal wear and tear and proper vehicle operation after twelve (12) months of date of purchase.

The Customer's Responsibility under this Warranty shall be to:

- Operate and maintain the vehicle as specified in the appropriate operator's manual.
- Give notice to MULLIGAN CARTS, LLC of all apparent defects within ten (10) days of discovery, and make the vehicle available at that time for inspection and repairs at MULLIGAN CART, LLC's place of business or service location. *ANY ISSUES WITH TIRES SHOULD BE REPORTED WITHIN THIRTY (30) DAYS FROM THE DATE OF PURCHASE.

LIABILITY LIMITATIONS: In no case shall MULLIGAN CARTS, LLC be liable for indirect, incidental, special, punitive or consequential damage, including but not limited to death, personal injury or property damage arising from or related to any alleged failure in cart or battery charger or any damage or loss to the purchaser or any third-party lost time, inconvenience or any economic loss, whether or not MULLIGAN CARTS, LLC was apprised of the foreseeability to such damage or losses. The right of the purchaser to recover damages within the limitations set forth in this section purchaser's exclusive alternative remedy if the limited remedy of repair or replacement of the vehicle fails of its essential purpose. Any legal claim or action arising that alleges breach of warranty must be brought within three (3) months from the date the warranty claim arises.

WARNING: Any modification or change to the vehicle, battery, and battery charger which alters the weight distribution or stability of the vehicle, increases or decreases the vehicle's speed, or alters the output of the battery charger beyond factory specifications can result in property damage, personal injury or death. These modifications will void the limited warranty. MULLIGAN CARTS, LLC disclaims responsibility for any such modifications, changes, or alterations, that would adversely impact the safe operation of the vehicle or battery charger.
